The Board of Trustees of West Ada School District will accept sealed bids for a new gymnasium and classroom addition to be built at the existing property at Spalding Elementary School, 12311 W. Braddock Drive, Boise, ID 83709. Bids will be received, opened and read aloud at the District Service Center, 1303 E. Central Drive, Meridian, Idaho 83642 on **Tuesday, May 22, 2018, at 2:00 PM MT.**

Bidders and other interested parties are invited to be present at the bid opening. A pre-bid conference will be held onsite **Thursday, May 10, 2018 at 1:30 PM MT.** Attendance by bidders is strongly recommended.

Bona fide Prime Bidders and major Sub-bidders may obtain one (1) complete set of bid documents at the office of Kreizenbeck Constructors, 11724 West Executive Drive, Boise, Idaho 83713 for a refundable deposit of \$200.00 per set. Bid documents are also available electronically at no charge through Kreizenbeck Constructors. **All bids must be submitted on the forms furnished and must be signed by the bidder.**

Drawings and Specifications, including bidding documents and conditions of agreement, will also be available through the Idaho AGC Boise Office and Blue Print Specialties.

Bids received after the bid opening time will not be considered and no bidder may withdraw his bid after the bid opening time or before the award of contract unless said award is delayed for a period exceeding sixty (60) days.

The Board of Trustees reserves the right to reject any or all bids, to waive any informalities, or to accept the bid or bids deemed in the best interest of West Ada School District.

Each bid must be accompanied by a bid bond, with a surety company licensed to do business in Idaho or a certified or cashier's check drawn on an Idaho Bank in an amount not less than five percent (5%) of the total bid, made payable to West Ada School District. In the event of bidder's failure to sign the contract or furnish the required Performance and Payment bonds, this bid surety will be forfeited.

Bidders shall hold a valid Idaho Public Works Contractor's License in accordance with Title 54, Chapter 19, Idaho Code as amended.

Prior to award of a contract for the work contemplated herein, West Ada School District shall conduct such investigation as it deems necessary to determine the performance record and ability of the apparent low bidder(s) to perform the size and type of project specified in such contract. Upon request, the bidder shall submit such information as deemed necessary for such investigation.

The successful Contractor(s) shall carry out his employment practices and payment of wages according to the provisions of Title 44, Chapter 10, Sections 44001 through 44-1006 Inclusive, Idaho Code as amended and shall comply with the Equal Employment Opportunity provisions as defined in the respective Code of Federal Regulations.
