The Board of Trustees of West Ada School District is requesting proposals for **Wide Area Network** to maintain intra-site Ethernet connectivity between schools and non-instructional facilities. Submission deadline for proposals is **Monday January 13, 2020, 10:00 AM MDT** at the District Service Center. Submittals are to be addressed to: **West Ada School District, ATTN: PURCHASING, 1303 E Central Drive, Meridian, ID 83642**. Proposers and other interested parties are invited to be present at the opening. The public opening will acknowledge receipt of proposals only and will not address pricing, details, or responsiveness of the offering. Proposals received after the deadline will not be considered and no proposer may withdraw his/her proposal after the deadline or before award unless said award is delayed for a period exceeding sixty (60) days.

Specifications, including bidding documents, specific instructions for submission of bids, and conditions of agreement, are available on the District's website at www.westada.org, at the District Service Center, via e-mail at purc_hasing@westada.org, or online through the FCC's E-Rate Universal Service Administrative Co. "EPC Web Portal" (<https://portal.usac.org/>)

Each bid exceeding \$50,000 must be accompanied by a bid bond with a surety company licensed to do business in Idaho or a certified/cashier's check drawn on an Idaho bank in an amount not less than five per cent (5%) of the total bid, made payable to Joint School District No. 2. In the event of the successful bidder's failure to execute the contract, this bid surety may be forfeited to Joint School District No. 2 at the sole discretion of the Board of Trustees.

The Board of Trustees of Joint School District No. 2 reserves the right to disregard all non-conforming, non-responsive or conditional bids, to waive any minor informality/irregularity, to reject all bids, or to accept the bid or bids it deems best.
