The Board of Trustees of Joint School District No. 2 dba West Ada School District, Meridian, Idaho (“District”), hereby announces that sealed bids will be received for the purchase of the following described surplus personal property. Sealed bids will be accepted at the District Service Center, 1303 E. Central Drive, Meridian, ID 83642, until **April 8, 2020, at 10:00 AM Mountain Daylight Time**. All properly submitted bids will be opened and read aloud immediately following the above date and time. All bidders and other interested parties are invited to attend the bid opening and reading.

The personal property subject to this sale are four (4) used modular building that have been used as classrooms, located at Mary McPherson Elementary School, 1050 E Amity Rd, Meridian, ID 83642.

TERMS OF SALE

The personal property is being sold “As Is” and “Where Is” without representation, warranty, or guaranty. Prospective bidders are invited, encouraged, and cautioned to inspect the personal property prior to submitting a sealed bid. The failure of any bidder to make such inspection will not constitute grounds for any claim or demand for adjustment or withdrawal of bid after the date and time for bid opening set forth above.

The bid range for the personal property is as follows:

Portable One is zero dollars (\$0.00) to five thousand five hundred dollars (\$5,500)

Portable Two is zero dollars (\$0.00) to six thousand nine hundred dollars (\$6,900)

Portable Three is zero dollars (\$0.00) to six thousand nine hundred dollars (\$6,900)

Portable Four is zero dollars (\$0.00) to six thousand nine hundred dollars (\$6,900)

Each bid must include a bid deposit in the amount of five percent (5%) of the amount of the bid as set forth in the bid documents. This deposit shall be in the form of a cashier’s check, certified check, or teller’s check (drawn on a bank with a branch in Ada County, Idaho) payable to the order of West Ada School District.
