The successful bidder will be required to furnish the additional necessary bond(s) for the faithful performance of the contract and supply the necessary insurance documents as prescribed in the contract documents. All properly submitted proposals will be opened and publicly read at the above hour and date.

#### PRE-BID MEETING
